Therefore, if you choose to enter onto an Owner's premises you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

ASSUMPTION OF RISK: I have read and understood the above warning concerning COVID-19. I hereby choose to accept the risk of contracting COVID-19 for myself in order to enter Owners' premises. I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to utilize Owners' premises in person rather than arranging for an alternative method of enjoying the same benefits virtually (e.g., Zoom).

WAIVER OF LAWSUIT/LIABILITY: I hereby forever release and waive my right to bring suit against Owners, the Rotary Club of Evergreen and the Evergreen Rotary Foundation, and their respective owners, officers, directors, managers, officials, trustees, agents, employees, or other representatives in connection with exposure, infection, and/or spread of COVID-19 related to the selection of and the use of Owners' premises. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

CHOICE OF LAW: I understand and agree that the law of the State of Colorado will apply to this
